

EXHIBIT "A"

AMENDMENT TO THE BYLAWS OF THE PRESERVE AT HAMMOCK CREEK HOMEOWNERS ASSOCIATION, INC.

1. Article IV, Section 3, <u>Annual Meetings</u>, shall be deleted in its entirety and be replaced by the following:

SECTION 3. Annual Meetings. The annual meeting of the Members of the Association shall be held each year during the month of February, beginning in 2010.
